SINCE ITS INCEPTION, MALT HAS ACQUIRED 69 AGRICULTURAL CONSERVATION EASEMENTS COVERING 44,213 ACRES. THESE EASEMENTS PROHIBIT DEVELOPMENT, SUBDIVISION, AND USES OR PRACTICES WHICH WOULD BE DESTRUCTIVE TO THE AGRICULTURAL VALUE OF THE LAND. AFTER THE EASEMENTS ARE RECORDED, OWNERS ARE BOUND BY ITS TERMS IN PERPETUITY. DURING THE YEAR ENDED JUNE 30, 2012, MALT EXPENDED \$2,894,173 ON EASEMENT ACQUISITION.
