THESE EASEMENTS PROHIBIT DEVELOPMENT, SUBDIVISION, AND USES OR PRACTICES WHICH WOULD BE DESTRUCTIVE TO THE AGRICULTURAL VALUE OF THE LAND. AFTER THE EASEMENTS ARE RECORDED, OWNERS ARE BOUND BY ITS TERMS IN PERPETUITY. DURING THE YEAR ENDED JUNE 30, 2015, MALT EXPENDED \$4,482,199 TO ACQUIRE SEVERAL CONSERVATION EASEMENTS.
