SINCE ITS INCEPTION, MALT HAS ACQUIRED 77 AGRICULTURAL CONSERVATION EASEMENTS COVERING 47,811 ACRES. THESE EASEMENTS PROHIBIT DEVELOPMENT, SUBDIVISION, AND USES OR PRACTICES WHICH WOULD BE DESTRUCTIVE TO THE AGRICULTURAL VALUE OF THE LAND. AFTER THE EASEMENTS ARE RECORDED, OWNERS ARE BOUND BY ITS TERMS IN PERPETUITY. DURING THE YEAR ENDED JUNE 30, 2016, MALT EXPENDED \$4,617,388 TO ACQUIRE 3 CONSERVATION EASEMENTS.
